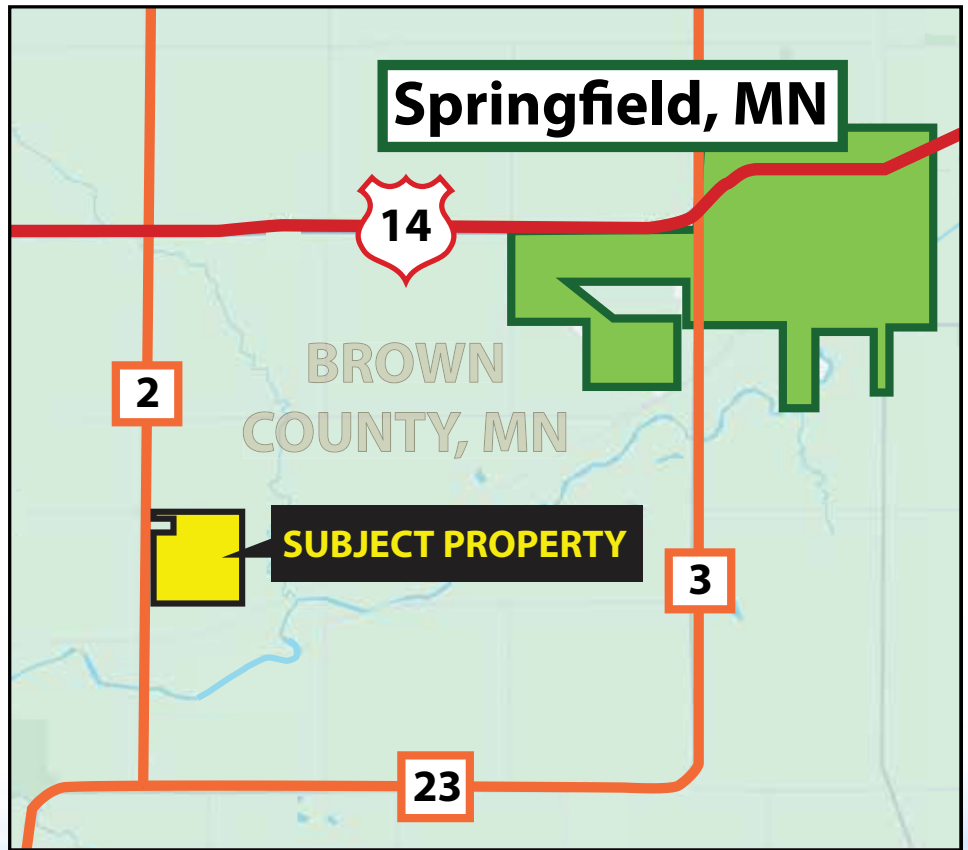
INTRODUCTION

Auction Note: This is exceptional corn and soybean land with highly productive soils in North Star Township near Springfield, MN. The cropland features nearly all Class II soils, predominately Amiret-Swanlake loam, Normania loam and Webster Clay loam soils. The Soil Productivity Index (SPI) is 93.8!

This property has tiling that was installed in 2014. The tenant applied fertilizer in the fall of 2024. 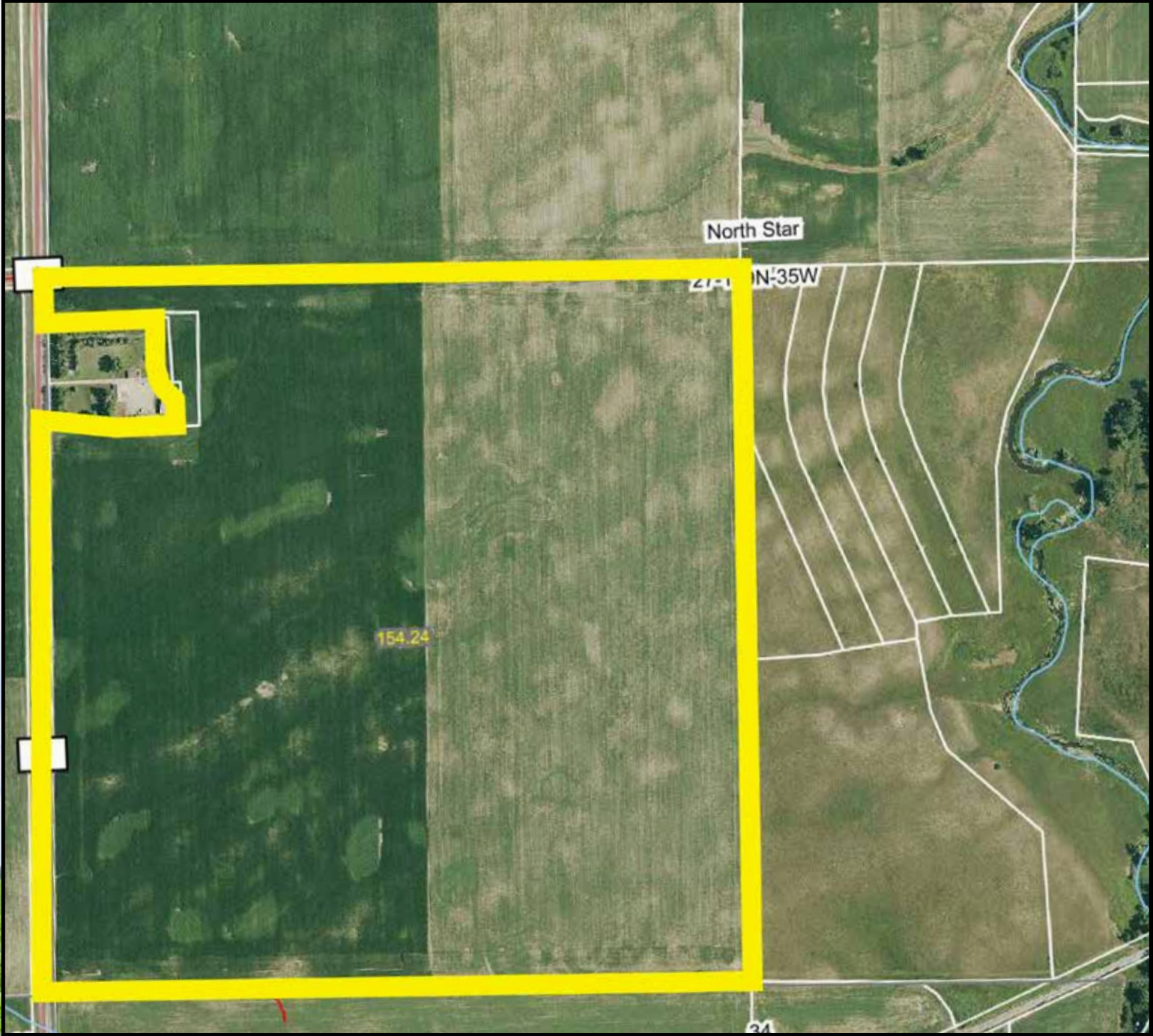

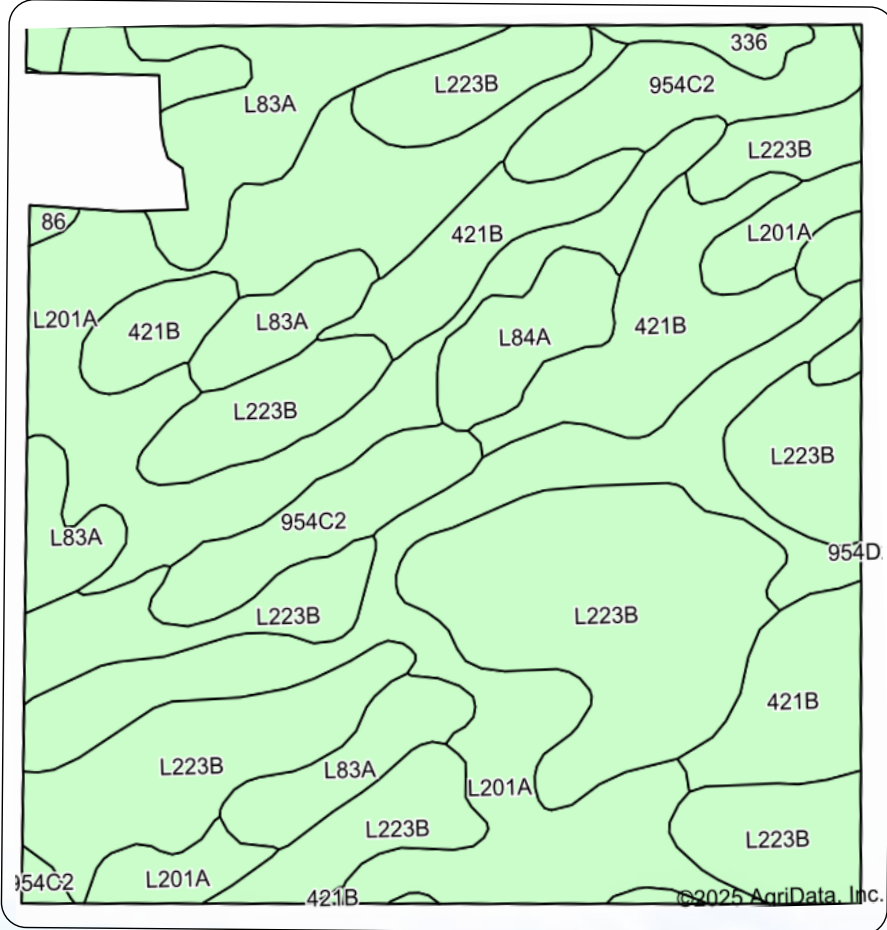

TERMS & CONDITIONS

I. Terms and Conditions of Auction
