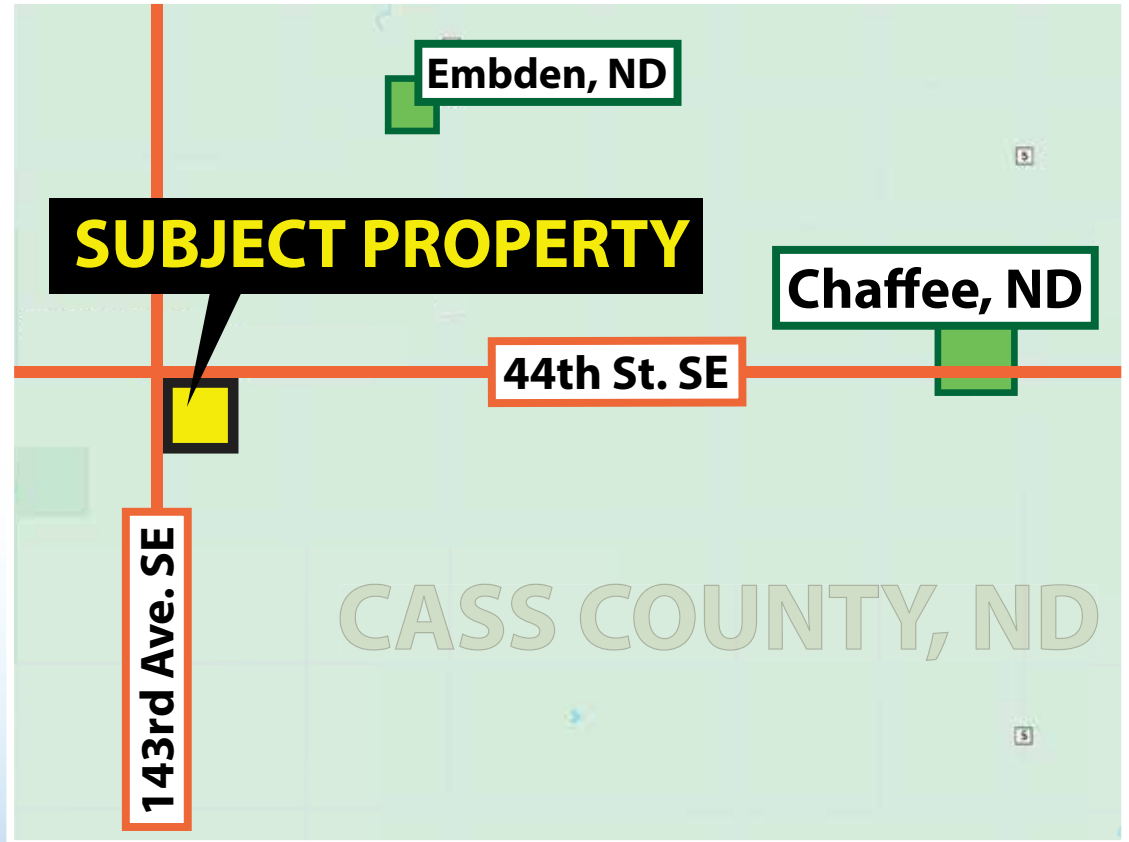

This auction features 158.09 +/- acres of farmland in Cass County a few miles west of Chaffee, ND. This parcel offers outstanding accessibility on County Rd. #6. The eastern portion of the land currently contains a 30 +/- acre alfalfa field. The land does contain a U.S Fish & Wildlife wetland easement and is available to farm in 2024.



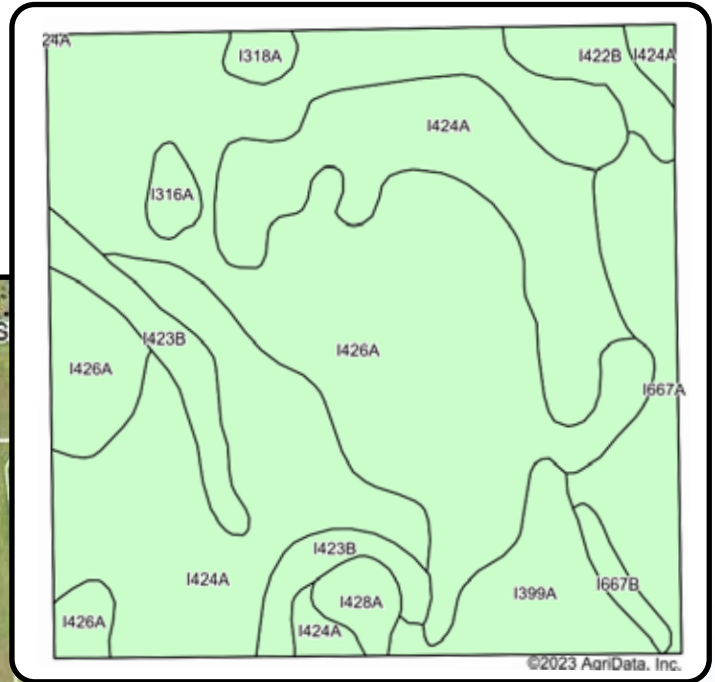
DRIVING DIRECTIONS

TERMS & CONDITIONS

I. Terms and Conditions of Auction

All bidding is open to the public without regard to a prospective bidder's sex, race, color, religion, or national origin.

A.
